instructor.
3. Regular classroom attendance and participation are a requirement, and failure to attend may affect my grade.
4. I understand that should withdrawal from this concurrent class be necessary, it is my responsibility to follow all University/College
guidelines for withdrawal, and especially receive the instructor's signature and acknowledgment. I understand that withdrawal from
the high school class does not automatically withdraw me from the University/College class. I understand that I must withdraw from
the University/College following their policy and deadlines and withdrawal grades will be reflected on my University transcript. If I fail
to properly withdraw from a college class I may receive a failing grade.
5. It is my responsibility to attend a Concurrent Enrollment orientation and consult with an academic advisor within 6 months of
starting Concurrent Enrollment.
6. I understand that the University/College grade will be posted on the University/College transcript.
7. I understand that enrolling for a concurrent class may affect my high school G.P.A., class rank, and total credits earned.
8. I understand that the University/College grade will be posted on my high school transcript and if I am eligible for additional high
school credit, that credit will also be posted on my high school transcript.
9. I understand that I may earn no more than 30 hours of concurrent class credit in a school year. The school year begins the first day
of summer vacation and ends with the last day of the high school spring semester. Should I earn more than 30 hours of concurrent
credit in the school year, I understand that it is my responsibility to reimburse Davis School District for incurred tuition costs.
